**Dear Cousins,**

The reason the Church expends vast fortunes on Temples and Genealogy is to facilitate the Temple ordinances required for each and every person who ever lived on the Earth. In his article "The Phenomenon That Is You," Ensign, Nov. 2003, President James E. Faust stated: "The Prophet Joseph Smith explained the terrible dilemma which would face God's children without temple work for our dead. Said he: 'One dies and is buried, having never heard the Gospel of reconciliation; to the other the message of salvation is sent, he hears and embraces it, and is made the heir of eternal life. Shall the one become the partaker of glory and the other be consigned to hopeless perdition? Is there no chance for his escape?'" (History of the Church, 4:425-26). Fortunately our ancestors will have the opportunity to receive and accept the saving ordinances as we identify them and complete these sacred ordinances for them by proxy. We do for them what they cannot do for themselves. It is a very satisfying experience."

One of the purposes of the John and Lydia Workman Family Organization is to fulfill the Priesthood Program of Redeeming the Dead. This year we have accomplished this purpose as follows:

1. Finished reviewing all entries in the four volume set of Pioneer Women of Faith and Fortitude by the Daughters of Utah Pioneers. Several hundred pioneer women were found in this set who were related to our Workman clan.
2. Finished integrating information from the 13,000 name Workman PAF file compiled by Arval and Julia Erickson Steadbeck. The information of thousands of individuals on the Organization's master PAF was updated and numerous individuals were added.
3. Continued integrating information from Descendants of John Workman, Capt. James Hanna, and Capt. John E. McConnell of York County, South Carolina by Perry . While these Workmans are not yet tied to our family line, it is only a matter of time.
4. Added information from numerous family group records, obituaries, e-mail, etc.
5. Provided Temple cards to approximately a dozen cousins who wanted to help perform Workman ordinances.

Genealogy and Temple goals for the immediate future are:

1. Finish integrating information from the Perry book (see 3, above).
2. Integrate information from Robert Bryner Colton's Ancestral Sequence of Jans William Woertman of Netherlands.
3. Integrate information from Robert Desmond Gibson's Our Workman Line in America From 1750 to 1991 .
4. Integrate information Julia Erickson Steadbeck's xyz PAF file. These are Workmans who have not yet been connected to our lines.
5. As always, continue attending the Temple.
